

# **Privacy Policy**

Thank you for visiting *Growth Coaching International*, a leading provider of coaching services to the education and corporate sectors. We respect and protect the privacy of our clients and prospective clients/visitors. This privacy policy tells you how we collect and use information.

The term "Personal Information" in this privacy policy means any information from which your identity is apparent or can be reasonably ascertained.

We do not collect Personal Information about you when you visit our website unless you or your employee has enrolled you, for example to: register for one of our programs; enquire about a program; make e-store purchases; or subscribe to our e-newsletter.

You can visit our website without telling us who you are or revealing other Personal Information. If you send us a contact or feedback form you do not need to identify yourself or use your real name.

#### Personal information

If, after browsing our website or materials, you do wish to sign up for our e-newsletters; register for one of our programs; enquire about a program or make e-store purchases we will collect the email address you nominate and any other identifying information you provide, such as a name, phone number and country. Please do not enter any personal or sensitive information.

Other than circumstances such as unlawful activity or serious threats to health and safety, we do not share Personal Information with other organisations - unless you request that your query is forwarded to one of our partners to be followed up by them. In Queensland, GCI has a partnership with the Queensland Educational Leadership Institute (QELi) and, under that agreement, program participant enrolment data is shared between our organisations for administrative purposes only. You will never be subscribed to any mailing list without your express opt-in with either GCI or QELi. Subscription to either organisation's communication does not imply consent to be subscribed to the others'.

You may opt out of further contact from us at any time simply by unsubscribing to our emails or by ringing our office on 1800 120 959 to ask us to remove your details from our customer database.

### How we deal with requests

You may request access to Personal Information about you that we hold and you may ask us to correct your Personal Information if you find that it is not accurate, up-to-date or complete.

### How we protect your Personal Information

Growth Coaching International's database is hosted in Australia. Access to the database is restricted to key Growth Coaching International administration staff and key staff of the database provider. Access to your Personal Information is restricted to employees who need it to provide benefits or services to you. We

train our employees about the importance of confidentiality and maintaining the privacy and security of your information.

To help protect the privacy of data and personal information we collect and hold, we maintain physical, technical and administrative safeguards. We update and test our security technology on an ongoing basis.

#### Website analytics
